We are proud to present our 2020 Annual Report of the Department of Child Abuse and Neglect Prevention. This report highlights our revenue sources, expenditures, grantees and program evaluation. The 2020 report also features our annual grantee training and public awareness events. Our agency, also known as The Children's Trust Fund, works diligently to secure the resources to award grant funding to community-based programs across Alabama that work to prevent child maltreatment. Our grantees incorporate the protective factors work in their service models and delivery.



These community-based programs focus on providing resources and training to ensure that children are raised in safe, stable and nurturing environments. ADCANP/CTF provides on-going training and technical assistance, as well as other resources, to each of the programs funded by our agency to ensure accountability and transparency. We are proud to partner with Auburn University's College of Human Development and Family Studies to evaluate the progress and success of each grantee. We are equally proud to collaborate with other state agencies and organizations as we work together to invest in programs that provide children and families with opportunities to thrive.

In the middle of the 2020 program year, the citizens of Alabama experienced school closings, stay-at-home orders, directly impacting priority family needs and the design of community services. ADCANP/CTF funded community partners adapted quickly. Local agency staff further proved their value and continue to do so throughout this challenging experience. Individuals and families were supported and empowered through the innovative and creative efforts of hundreds of community partner agency staff. Virtual one-on-one sessions and group program delivery were timely and essential lifelines for families. The staff at ADCANP/CTF worked tirelessly to support funded program staff and created a COVID-19 Resource Guide for communities. While times remained uncertain, ADCANP/CTF and the programs it funds remain steadfast in networked efforts to strengthen families and reduce risks for children, one child and family at a time.

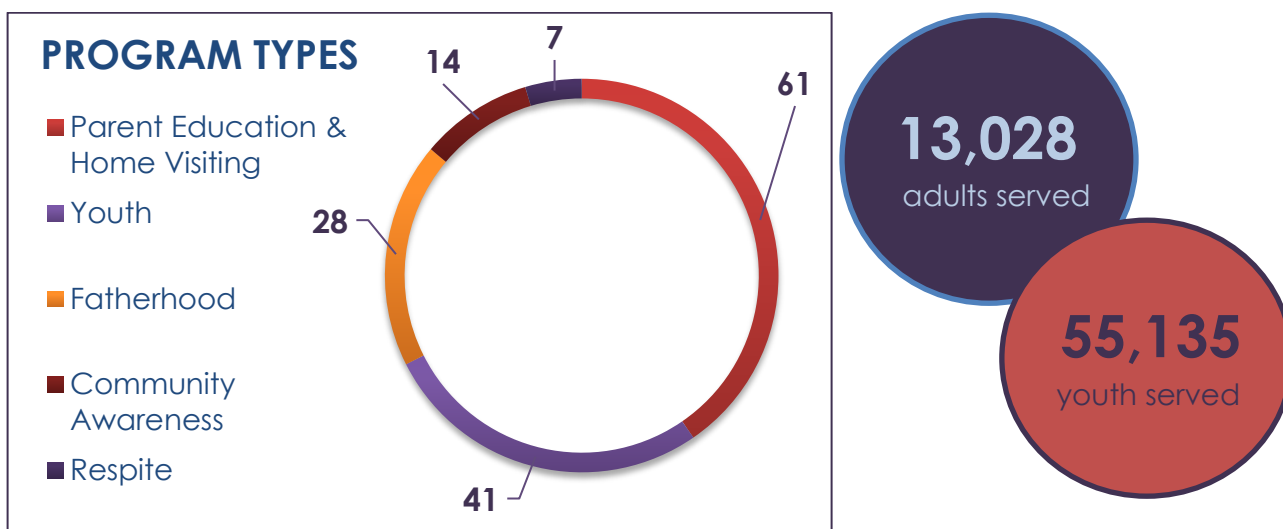

PREVENTION PROGRAMS

Program Highlights

During the 2019-2020 Program Year, the Department awarded over \$8 million from four primary federal and state funding streams to fund two statewide initiatives and 151 community-based prevention programs that applied for program grants. The funded prevention programs provided services to 55,135 youth and 13,028 adults, as well as an additional 614,320 individuals attended community awareness programs and presentations about the prevention of child maltreatment. Community awareness activities also included helpful information shared through media and social media. Approximately 3,182,837 exposures/impressions were generated. With the challenges of COVID-19 this year, ADCANP/CTF funded community partners adapted quickly, adjusting and restructuring their delivery of program services, and often pivoting to focus on the most pressing needs for economic, housing, and food security. In total, **682,483** Alabama citizens were impacted by ADCANP/CTF-funded programs during the 2019-2020 grant period.



Evaluation Highlights

From August 2019 to July 2020, the Department worked with an independent research team in Auburn University's Human Development and Family Studies Department to conduct a systematic evaluation of its funded programs to document the magnitude of the outreach and effects of the funded programs statewide for youth and parents served. Key findings from the evaluation include:

- Parent education and home visiting program participants had statistically significant improvements in: parenting skills & child development knowledge, knowledge & use of support services, stress management, skills to manage maltreatment risk, and understanding various forms of maltreatment.
- Youth focused program participants revealed statistically substantial improvements in: social skill development, improved abuse awareness, self-confidence, cooperative behavior, and commitment to avoid risky & delinquent behavior.
- Fatherhood Program participants had statistical improvements in: job skills, positive parenting behavior, and involvement with their children, as well as complying with child support obligations.
- Respite care program participants had statistical improvements in positive views of the child and stress level.

“Prevention programs funded by ADCANP/CTF have documented important positive effects for adults and youth in Alabama served in 2019-2020. Evidence shows these programs enhance protective factors that are associated with the reduction of risks and the significant human and economic cost of child abuse and neglect in our state.”

PROJECTS

Strengthening Families™ Trainings

We have continued to work with the Alabama Network of Family Resource Centers to further implement strategies that strengthen families and build upon the five protective factors. Through continuous trainings and monthly calls to collaborate on our collective work, Alabama's Certified Trainers are continuing to ignite a statewide movement on Bringing the Protective Factors Framework to Life in Your Work. Before the pandemic hit, we joined the Alabama Network of Family Resource Centers for in-person trainings to DHR Supervisors and County Directors in the Strengthening Families Protective Factors Framework.

Strengthening Families and Communities- Preventing and Addressing Trauma



We also received a grant from the Alabama Department of Mental Health and partnered with the Alabama Network of Family Resource Centers to provide 22 virtual training on Strengthening Families™- Preventing and Addressing Trauma. The one-day training session was upbeat and interactive, and participants had a broader understanding of the long-term effects of childhood trauma and Strengthening Families™: Bringing the Protective Factors Framework to

Life in Your Work. Participants shared ideas with others and came up with concrete steps for individuals and communities to support strong families. The trainings reached nearly 400 participants, including grantees, teachers, higher education professionals, mental health substance abuse prevention workers, DHR staff, juvenile probation officers, youth service workers, housing authorities, and participants also gained 6.5 contact hours for their participation.

During the early stages of the pandemic, Alabama, along with 13 other states participated in on-going bi-monthly virtual meetings with the National Governor's Association. The Governor's Office invited Sallye Longshore, CTF/ADCANP Director, and representatives from DHR, Rehabilitation Services and Education to join on the five-member "Alabama team". As families and communities face increased uncertainty due to the COVID-19 pandemic, the cohort linked governors' offices, child welfare leaders, state human services and education officials, and nonprofit partners to support child and family well-being.

ACTIVITIES

Child Abuse Prevention Month

With the pandemic hitting mid-March, Child Abuse Prevention Month looked different with many in-person events being cancelled. Many of our grantees came up with creative ways to bring social media awareness to Child Abuse Prevention Month. Governor Ivey also recognized April as Child Abuse Prevention Month with a proclamation. In addition, Prevent Child Abuse America launched a virtual pinwheel garden for Child Abuse Prevention Month. For just \$10, individuals could plant a virtual pinwheel. Since we couldn't all be together planting pinwheels, this was a virtual way we all come together. With over \$300 raised for child abuse and neglect prevention programs in the state, we're pleased to report we had the 2nd largest pinwheel garden in the nation!



Grantee Training

We hosted the annual Children's Trust Fund Conference for our 2019-2020 grantees on October 28-29, 2019 at Ross Bridge in Birmingham. The training provided over 200 attendees with informative speakers, exhibitors, and time to network with other funded prevention programs. We also hosted a training for our TANF grantees focused on their specific grant guidelines as well as tools and resources for engaging fathers.

Before the 2020 Legislative session started, we hosted check presentations in each of Alabama's Seven Congressional Districts. The check presentations highlighted the critical programs our grantees provide in their community to members of the State Legislature as well as to media representatives.



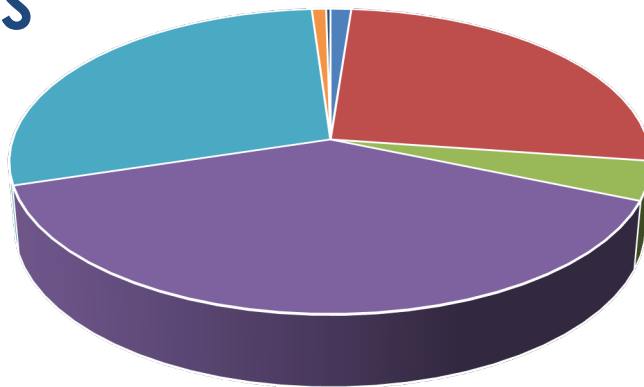
Conferences

We continued to present on our prevention work at conferences throughout the state including: Doing What Matters for Alabama's Children, Alabama Human Trafficking Summit and many more.



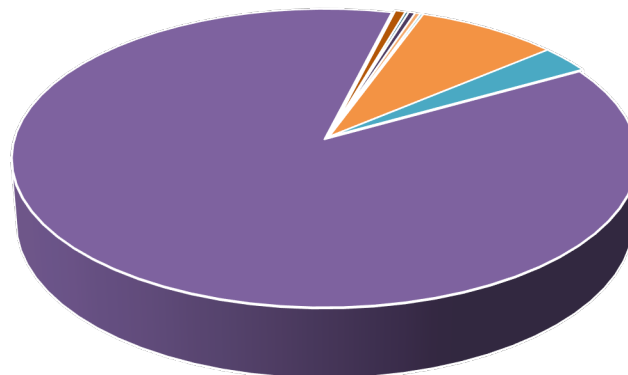
